Additional Information: For our regular Kiddushes after Shabbat services, sponsors do their own shopping. Our new policy strongly encourages a move towards plant based food. We never serve meat at Kiddush, but some people do bring fish and eggs sometimes. This is a work in progress: the CAP Advisory Group will be helping to make plant based options more accessible to Kiddush sponsors. This year the shul served chicken for one Friday night dinner, with a vegetarian option. We hope to reduce even that amount of meat that is served.

We are prepared to initiate a composting program for the building once construction is completed at the Myerberg. Congregants regularly take leftover food home at the end of our events- we have made a paradigm shift that is it a positive thing to take food home. We are also being careful about opening items as needed, putting out less food, etc.

Additional Information: *In May 2025, our community held a Green Mitzvathon that engaged congregants in collective climate action grounded in Jewish values. Participants committed to and completed a wide range of environmentally focused mitzvot, including reducing household energy use, adopting more sustainable food practices, supporting local environmental initiatives, and learning about climate justice. The Mitzvathon strengthened community engagement, raised awareness of practical steps individuals can take to address the climate crisis, and reinforced our congregation's ongoing commitment to environmental stewardship and collective responsibility.*

We hosted Scholar in Residence Rabbi Nina Beth Cardin for an environmental shabbaton, including vegan meals along with participatory Friday night, Saturday morning and Saturday evening services that included environmental education, activities and reflections around each service and discussions around caring for the planet and reducing waste led by Rabbi Cardin afterwards. The weekend culminated with an environment fair on the Sunday with more than 40 organizations and speakers providing educational information, more vegan meals, give aways, and family oriented learning activities at booths for more than 200+ participants. Our congregation was recognized by Adamah with an Environmental Leadership Award for this work.

In 2026 we will launch a quarterly environment newsletter, plant trees, host a movie night and sponsor Tu b'shvat.

Additional Information: *In 2024, the Social Action Committee (SAC) asked the Finance and Fundraising Committee (F&F) to evaluate investment options aligned with Chevrei Tzedek's Climate Action Plan (CAP). In response, an ad hoc Investments Subcommittee reviewed 171 mutual funds identified by the US Sustainable Investment Forum (US SIF). The subcommittee screened and evaluated these funds using sustainability ratings and analyses from Ethos and Morningstar, ranking them based on portfolio composition, historical performance, expense ratios, and sustainability criteria.*

Following this review, the subcommittee recommended replacing the congregation's existing mutual funds with two alternatives: the Calvert US Large-Cap Growth Responsible Index Fund I (CGJIX) and the Praxis Growth Index Fund A (MGNDX). Both funds receive strong ratings from Morningstar and Ethos, demonstrate solid long-term performance, maintain relatively low expense ratios, and prioritize investments in clean and environmentally responsible companies. In addition, CGJIX avoids or limits exposure to companies that violate international norms, including the UN Global Compact and the Universal Declaration of Human Rights.

In February 2025, Chevrei Tzedek's Board (the Coordinating Committee) formally adopted a resolution to invest in mutual funds consistent with the CAP. The treasurers subsequently began a phased transition, gradually divesting from existing holdings and

investing in the recommended funds.

As part of this effort, the Investments Subcommittee also hosted a community webinar, “Investing in Our Future: Jewish Values, Financial Choices, and Climate Action,” featuring Jewish investment professionals. Co-sponsored by Adamah and the Baltimore Environmental Sustainability Network (BESN), the program took place on December 14, 2025. Adamah is working with a leading electrification nonprofit that is focused on electrifying our homes, businesses, and communities. They develop accessible, actionable data and tools to make going electric easier, with a mission to help us save money, tackle climate goals, improve health, and build the next generation of the clean energy workforce. They are working to understand the broader emissions-mitigation and cost-saving potential of electrification. Our partnership will bring insight into the nonprofit sectors of America and, we believe, invaluable opportunities for our community.

Our Coordinating Committee and Rabbi continue to support our climate work.

We participated in reverse Tashlich, partnering with Repair the Sea and Chizuk Amuno Congregation. We adapted the Green Kiddush policy and continue to work on best implementation. We established and will continue our new format for the Yizkor book, and have greatly reduced paper copies of announcements and programs and choosing to share those digitally. We have researched compost companies, secured funding to begin the program, and are awaiting conclusion of construction at the Myerberg so that we can proceed with a composting program.
